

Data privacy policies YMoCA 2021-2022.

Thank you for being part of the BritchamDR Young Musician of the Caribbean Award 2021-2022 (indistinctly the “BritchamDR Young Musician of the Caribbean Award 2021-2022” or the “Competition” organized by the British Chamber of Commerce in the Dominican Republic (BRITCHAM DR) , the Associated Board of the Royal Schools of Music (ABRSM) and Bangor University, hereinafter referred to as the “Organizing Committee.” In light of the above, you have provided the Organizing Committee with personal information on the application form. Within the personal information provided to the Organizing Committee by you is included, without limitation, your name, sex, date of birth, address, email address, telephone, name of the educational center where you study, recordings and photographs for participation in the competition, a copy of your birth certificate or other identity document (hereinafter “Personal Information”).

You have also provided personal information of your parents and / or legal guardians, in the case of minors. This personal information includes your names, email address, telephone, identity document and consent of your parents and / or legal guardian (also considered as “Personal Information”).

The Organizing Committee is responsible for handling said Personal Information, as well as its contributions, in accordance with the provisions of Law No. 172-13 on Integral Protection of Personal Data Settled in Archives, Public Registries, Data Banks or Other Technical Means of Treatment of Data Intended to Give Reports, whether they are public or private. The Organizing Committee has a legitimate interest in using your Personal Information for artistic, literary and research purposes, as well as to comply with its agreement with the Organizing Committee and with the other legal obligations that may arise as a result of said agreement.

In all the places where it is imperative to use your Personal Information, the Organizing Committee undertakes that they are used in a correct way and that it does not affect or violate the interests of the competition or yours.

Your auditions and submissions from the category auditions could be used in future editions of the competition. The finals of the competition could be recorded for broadcast on different television channels and other media.

If you are selected as one of the finalists, the Organizing Committee can retain your contributions in perpetuity. We will also retain other information (such as the application form), your Personal Information and any information collected in relation to eligibility to participate for a period of 10 years. If, on the contrary, you are not selected to participate in the competition, we will delete your data no later than 24 months after the completion of the selection process.

Terms and Conditions YMoCA 2021-2022.

As a participant, I agree to take part in the BritchamDR Young Musician of the Caribbean Award 2021-2021 competition, organized by BRITCHAM RD, ABRSM and Bangor University, and consequently, I accept all the rules, terms and conditions of said competition. As a condition of entry, I voluntarily consent to my participation in the competition being recorded and photographed.

I further acknowledge that I might be filmed and recorded at any time and during the audition process and that the results of such filming and recording may be used in and in connection with the competition and its sponsors / business partners.

I understand the style, nature, format and content of the competition, including that my performance will be subject to the comments of the judges, the media and / or the general public, and third parties that make up the competition, whose comments can be positive and / or negative, so I give my free and deliberate consent to them and agree to participate on this basis and, by signing the registration form, I give my consent to participate in the competition.

Through these terms and conditions, I give my consent to the Organizing Committee all the necessary rights for the purposes of using the content created by me in this contest, including, but not limited to, photographs and recordings without restrictions in all media that The Organizing Committee uses it as a means of publicity in the competition. In the same way, I give my consent for the Organizing Committee to edit, copy, alter, translate and adapt the content related to my participation in the competition and I disclaim any right to use the content created in the competition. I declare to behave appropriately when participating in the competition, agreeing to comply with all the procedures and rules of the competition. The Organizing Committee reserves the right to disqualify the participant in the event of any voluntary non-compliance, negligent act or omission on their part, or for any other reason, which will be at the sole discretion of the Organizing Committee.

I hereby agree that I will notify the Organizing Committee if I am a party or subject to any agreement and / or management agreement and / or agency agreement.

By this means, I authorize the Organizing Committee to use photographs and recordings without restriction on all platforms that it deems appropriate for the purposes of advertising the competition during and in editions after they are held. In particular, I authorize the Organizing Committee to unlimited use of the content produced in the competition for the corresponding purposes. I give my consent to the Organizing Committee to use my name, biography and photographs of myself at any time and place in the world in the promotion and publicity of the aforementioned competition in any digital and physical format.

I certify and attest that I have completed the entry form for the competition and I acknowledge that the Organizing Committee has the right to disqualify and withdraw any prize or reward obtained from any participant in the selection process or the competition in case of violation of these terms and conditions and any legislation related to intellectual property and copyright. I understand that if I do not appear for the rehearsals, I will be automatically disqualified from the final stage of the competition. I understand that, in case of reaching the final stages of the competition, I may be contacted and requested additional information about myself, including a data verification.

I accept that the Organizing Committee may suspend the competition at any time for the reasons that it deems pertinent.

I consent to my personal information being used by the Organizing Committee and any third party that is part of the assembly and organization of the competition for matters related to it.

I have obtained the consent of my parents and / or legal guardians prior to providing their personal data in the registration form. I understand that I can withdraw my consent to the use of my personal data before the start of the competition. The Organizing Committee will not be legally responsible for any loss, damage or

injury to my person or my property caused during the celebration of the competition, except that said damages occur due to the negligence of the Organizing Committee.

I agree that my participation in the competition will not contain any defamatory content or that violates the laws and customs of the Dominican Republic.

I am free to sign this Agreement and I hereby grant pure and simple discharge to the Organizing Committee regarding all actions, procedures, claims, damages and other responsibilities that may be imputed or incurred by the Organizing Committee as a result of the breach of any of my guarantees, representations, obligations or commitments contained in these Terms and Conditions. I agree that, in case of breach of these Terms and Conditions by the Organizing Committee, I will not have the right to any legal action.

The ordinary courts of the Dominican Republic will have exclusive jurisdiction in relation to the terms and conditions of the agreement contained in this authorization, which will be interpreted in accordance with the laws of the Dominican Republic.
